Prince Duccio Corsini is a top owner of the Corsican Mafia and he is an overseer of a private Swiss banking and human trafficking operation in Gstadd, Switzerland. The Scherz family of Gstadd run Gstadd

and their coat of arms is a heart. The Corsinis coat of arms is shaped as a heart and the Italian word Core or Coure has the meaning of heart. Prince Duccio also oversees the DEA. Lucien Conein was from Maryland and he was a documented associate of the Corsican Mafia and he worked for the OSS, CIA, and then DEA. The Corsican Mafia have a headquarters in Baltimore, Maryland and they oversee a large heroin and opium trafficking ring from Turkey, the Middle East, and Afghanistan to ports on the East Coast. The Corsican Mafia then traffics the heroin or opium to the Lucchese crime family which then provide it to the modern day Drug Council run by black gangster rappers. Corsica is named after the Corsinis and uses a black Moor on its coat of arms and flag. Moors, Arabs, and Africans invaded Europe and trafficked natural white Europeans for over a thousand years. The Corsinis also owned banks in Florence and London.

Prince Charles Bonaparte is a top owner of the Corsican Mafia and he is also top manager of various French billionaires and Zionists. The Bonapartes created the FBI through Charles Bonaparte the former Attorney General of the United States and the Bonapartes also married with the Italian Gotti family who are top members of the Gambino crime syndicate. Charles Bonaparte was born in Baltimore, Maryland because the Corsican Mafia are headquartered there. The Bonapartes founded the modern movement of Zionism when Emperor Napoleon Bonaparte proclaimed for all Jews to settle in Jerusalem. The Bonapartes originated from Florence and Corsica and are really relatives of the Corsinis. The Jesuits were banished from most of Europe to Corsica and Napoleon Bonaparte was born and from Europe and he made war on all the European nations that banished the Jesuits.

Bernhard Arnault is worth 80 billion and he is an agent of the Bonapartes, Medicis, and Corsinis and he operates as a financier for organized crime like the Corsican Mafia and Milieu or French gangs. Arnault funnels criminal profits through his 80 billion dollar bankroll criminally which is money laundering.

Prince Girolamo Guicciardini-Strozzi is a blood and adrenochrome trafficker through his wine company and he also finances Wiccan covens. The Strozzi work closely with the Medicis.

Francois-Henri Pinault with his Hollywood wife Salma Hayek. Most of the major actresses in Hollywood are obsessed with raping, murdering, and cannibalizing the private parts of male children including Salma Hayek. Pinault is worth over 30 billion and he is an agent of the Medicis and Strozzi and his Group Artemis company finances satanic witches and child trafficking networks.

Victor Sassoon is a businessman operating from Singapore and he is involved in money laundering and child trafficking. The Sassoons are a high level Zionist-Jewish bloodline that own properties and banks all over Hong Kong and India. They are known as the "Rothschilds of the East" and they are closely related to the Medici, Dreyfus, Pritzker, and Hermes-Dumas families which are all really descendants of ancient Egyptian-Chaldaeian bloodlines.

Prince Lorenzo de Medici is an overseer of the Hermetic Order of the Golden Dawn and he oversees banking connections in Portugal, Switzerland, and Italy. The Federal Reserve Bank of New York has had several Jesuit educated presidents including William Joseph McDonough who was the head of the FRBNY during 9/11 when the mafia and the mafia controlled port authority stole the gold that

FDR confiscated from the American people through his Executive Order 6102. 9/11 was partly a gold heist.

Julia Louis-Dreyfus is a high level witch in Hollywood and her family are worth billions and they are managed by the Medicis. The Dreyfus family have had several members who were knighted under the House of Bonaparte and they work closely with the Medicis as well as the Dutch royals. The Dreyfus family own Louis-Dreyfus Group an international shipping, agriculture, communications, and banking company that is involved with chemical warfare and human trafficking. The Dreyfus family also work with RAND Corporation and are involved with artificial intelligence weapons. The Dreyfus family own a private bank in Switzerland called Dreyfus and Sons which has been fined for enabling tax evasion and money laundering in the hundreds of millions. Julia Louis-Dreyfus manages a large cult of demented witches that burn children alive and spew out childish lies and blasphemies constantly.

Prince Lorenzo de Medici-Tornaquinci-Foscari with Princess Elisabetta de Medici-Tornaquinci-Foscari and they are part owners of the Gay Mafia in the fashion industry and top managers of the Hermetic Order of the Golden Dawn. The Medicis have a statue of Hermes at their palace in Rome. They are the top architects of Hermeticism and Alchemy.

Axel Dumas and the Hermes-Dumas family are worth 30 billion and they are agents of the Medicis and financiers of the Hermetic Order of the Golden Dawn a secret society of alchemists which are involved with chemical poisoning and chemically hacking the biology of people.

Marchese Vittorio Frescobaldi is a blood and adrenochrome trafficker through his wine company and he works under the Aldobrandinis.

Marchese Niccolò Incisa Della Rocchetta is a blood and adrenochrome trafficker through his wine company and he has an alliance with the Chigis-Albani Della Roveres and Sayn-Wittgensteins.

Marchese Piero Antinori is a top Florentine blood trafficker and he finances organized street gangs in Latin America like MS13 and in Asia like the Triads. The Antinoris are also financiers of the Apulian Mafia and they have an alliance with the Aldobrandinis. The Aldobrandinis married with the Antinoris and now own one of their palazzos in Florence and also took their Apulian titles of the Dukes of Brindisi.

Marchese Lamberto Frescobaldi is a blood and adrenochrome trafficker through his wine company and he works under the Aldobrandinis.

Prince Donatus von Hessen with Princess Floria von Hessen. Prince Donatus is a high level authority over the bloodlines of the Holy Roman Empire and a top manager of militarized Nazism and Zionism. The Hesses are holocaustic Nazis that burn children alive. Nazis are Satanists. During WWII at least 4 princes of the House of Hesse were members of the Nazi military. Prince Donatus is the primary owner of the Iron Horsemen motorcycle gang. The House of Hesse were the Rothschilds original employers which would finance wars on both sides and Hessian mercenaries would then fight wars on both sides. The

House of Hesse also co-founded Commerzbank.

Max Warburg is an owner of MM Warburg Bank and he is a top Zionist who finances militarized gang stalking, directed energy weapons, and wars. The Warburgs and Hesses were co-founders of Commerzbank and the Warburgs were involved in establishing the United States Federal Reserve. The Jewish Warburgs also directly financed Adolph Hitler through Max Warburg who was on the General Council of Reichsbank under Hitler. There were Jewish Nazis during WWII like George Soros and they were called Mischlings. Adolf Hitler also appointed Jews to the General Council of Reichsbank. There were at least 100,000 Jews that were Nazis called Mischlings.

Count Patrick Faber-Castell with Nicole Junkermann and Count Patrick is a wealthy businessman and a financier of trolls and shills. The Faber-Castells are officially worth at least 1 billion.

Count Andreas von Hardenberg with Countess Isa von Hardenberg and Count Andreas is a German banker. The Hardenbergs also merged a branch with the Spanish Bourbons which are the royals of Spain.

Laura Bush has high authority within politics through the Bush-Walker family and she oversees a large faction of the female Conservative politicians and reporters. The Bushs caused the deaths of over a million people in Iraq and hundreds of thousands in Afghanistan. The Bushs were the primary architects of 9/11 a documented government sponsored and government orchestrated terrorist attack on Americans. The Bush family have a close alliance with the Spanish royal family the House of Bourbon. Laura Bush's mother was a Hawkins. The Hawkins family are also married with the House of Bourbon which are owners of the Mexican drug cartels. King Juan Carlos of Spain visited Bush Jr's ranch during his presidency. The Bushs have a drug trafficking deal with the Bourbons and their cartels which traffic drugs and children across the Texas border where the Bushs reside.

Joachim Olearius is a top executive of MM Warburg bank in Germany. MM Warburg is a powerful German bank involved with money laundering, criminal financing and specifically financing militarized gang stalking. The Warburg family are also part owners of Warburg Pincus and the Swiss bank UBS which was originally part of S.G. Warburg & Co.

Prince Ludwig of Salm-Salm with Princess Ulrike of Salm-Salm and they work under the Hesses. The nobles and royals of Hesse and Westphalia have a close alliance and specialize in military.

Countess Viktoria von Dem Bussche is a top manager of Alchemical cults like the Rosicrucian Order and Hermetic Order of the Golden Dawn as well as an overseer of the pharmaceutical industry. The Von Dem Bussches have a secret alliance with the Medicis who owned Botanical gardens in northern Italy because they taught the Germans alchemy which is chemical witchcraft and covert chemical warfare.

August Busch IV is a billionaire and top authority in the United States as well as an owner of the Sons of Silence motorcycle gang which use the Anheuser-Busch beer logo for their gang symbol.

Prince Ferdinand von Habsburg with Countess Tita von Hardenberg.

Jonathan Bush founded AthenaHealth and he is a top commander of Luciferian gang stalkers and Alchemical cults that are involved with burning children to death also called holocausts. Jonathan Bush's father is a banker and a member of Skull and Bones. The Nazis used the Skull and Bones symbol for their SS. Princess Mafalda von Hessen is a manager of a coven of Wiccan-Amazons. Princess Mafalda married two Italian counts and was most recently married with the Brachetti-Peretti family with Count Ferdinand whose second wife was Nicole Junkermann a business associate of the Faber Castells which are currently married with the Hesses.

George Walker Bush is a member of Skull and Bones and he is a top authority over the Department of Defense, DARPA, CIA, Raytheon, Northrup Grumman, and various federal agencies and various military industrial companies. The Bushs also created the DHS which finances domestic terrorists or gang stalkers. The Bush family merged with the Walker family. The CIA is named after George Herbert Walker Bush and Gina Haspel the current CIA Director was born Gina Walker. DARPA is headed up by Steven Walker. Vanevar Bush founded Raytheon and Wes Bush is a top executive at Northrup Grumman. The Bushs use directed energy weapons like the Active Denial System on Americans who speak out against them.

Richard Haass is the President of the Council on Foreign Relations which is a private and non elected organization that influences the foreign policies of the United States. Richard Haass is a Jewish agent of the Bush family where he was Director of Policy Planning under President George Walker Bush and prior to that he worked at the Department of Defense and as an assistant to President George Hebert Walker Bush.

Prince Philipp von Hessen with Princess Laetitia von Hessen and Prince Philipp is a top owner of the

Hessian motorcycle gang and Prince Philipp also claims the title of "King of Finland." The House of Hesse own several large palaces in Germany and several German hotels through their foundation. The Hesses also manage German intelligence agencies and INTERPOL which was taken over by the Nazis during WWII. Today Jurgen Stock is the Secretary General of INTERPOL and he is from the German state of Hesse and he was educated at the University of Giessen which was founded by the Hesses and Habsburgs.

Prince Max von Baden the Duke of Zahringen is a top authority over the Holy Roman bloodlines and he is a part owner of various motorcycle gangs around the world. The Zahringens also established the city of Berne, Switzerland and the Badens are married with the Bernadotte royals of Sweden which covertly originated from Berne, Switzerland before migrating to Berne, France and being put into power in Sweden by the House of Bonaparte. The Badens and Wurttembergs own the Warlocks MC gang headquartered in Pennsylvania. The Baden-Zahringen coat of arms is a phoenix and the Warlocks use the phoenix as their gang symbol. The Warlocks of the United States have a chapter in Baden-Wurttemberg, Germany called the Phoenix Club.

Prince Max of Bavaria and Princess Elisabeth of Bavaria and they are top authorities over Nazism, Zionism, Goldman Sachs, and the Bavarian Illuminati and they are overseers of Scottish Rite Freemasonry. Adolf Hitler was from Bavaria and he was a member of the Bavarian royal army. The Goldman and Sachs families were Court Jews from the Kingdom of Bavaria who founded Goldman Sachs for the Bavarian royals. Adam Weishaupt founded the Bavarian Illuminati in 1776 at Ingolstadt University a college created by the Bavarian royals the House of Wittelsbach.

Prince Dominique de la Rochefoucauld-Montbel is the Grand Hospitaller of the Sovereign Military Order of Malta and a top authority over various militaries around the world. The Rochefoucaulds are French nobles that also have Bavarian titles of nobility and they married with the Roman Aldobrandinis and the Rochefoucauld-Aldobrandini Princess Anna was married to Prince Ludovico Chigi-Albani Della Rovere the Grand Master of the Sovereign Military Order of Malta during WWII.

Queen Silvia Bernadotte of Sweden with Prince Leopold of Bavaria and Princess Ursula of Bavaria are overseers of Nazism, Zionism, Goldman Sachs, and the Bavarian Illuminati. When these royals get exposed they use Court Jews to finance Nazi propaganda where they attack people for exposing royals and then blame all Jews for all evils. That is their same old constant program.

George Kaiser is worth about 7 billion and he is a top Zionist leader in the United States. Kaiser owns the majority of BOK Financial Corporation which owns various banks in the United States and is involved with the oil industry. George Kaiser is also the primary owner of the Oklahoma City Thunder NBA team and he is involved with rigging games for mafia bets.

King Carl XVI Gustaf Bernadotte of Sweden with his son Prince Carl Philip Bernadotte the Duke of Varmland. They are top overseers of various navies around the world. They are wearing naval caps because they are members of the royal Swedish navy. The Vikings who were Scythians that invaded the northern nations of Europe around 200 AD stole ship building technologies from the natural settlers of the Nordic region and they then raided the rest of Europe. The Bernadottes or Swedish royals are financiers of Viking cults connected with white supremacist groups like the Lynwood Vikings a white

supremacist organization that operates in the police departments in California and the West Coast.

Jacob Wallenberg and his family controls hundreds of billions in assets and companies and they use their control over European companies as leverage over the European Union through the European Round Table of Investments. The Wallenberg family are members of the European Round Table of Investments which is a secret society of European businessmen that are mostly from Sweden, France, Germany, and Italy. Jacob Wallenberg is also a knight of the Bonapartes Legion of Honor and a member of the Bilderberg Group.

Prince Aldabert von Hohenzollern with Princess Eva-Maria von Hohenzollern and Prince Aldabert is an owner of the German Gremium motorcycle gang. Gremium uses the Prussian Iron Cross and the colors black and white. The Hohenzollern coat of arms uses black and white. The House of Hohenzollern also run German Freemasonry and black and white are common symbols used by Freemasons. Three of the five German Masonic organizations were founded in Prussia.

Prince Wolfgang of Bavaria with Princess Tatiana of Bavaria and she is traffics human flesh and blood through the medical industry. The Bavarian royals specialize in insane and demented blasphemies as well as electronic harassment.

Michael Bloomberg a Jew who is worth 50 billion with Joseph Ratzinger the Bavarian Nazi Pope. Joseph Ratzinger was a Nazi youth from Bavaria. Adolf Hitler was a member of the Bavarian Royal army. The Waltons also sold several of their former Walmart stores to the United States government which have been used for holding and trafficking immigrant children who were forcibly taken from their parents. The Waltons finance child trafficking and pedophilia networks. The Waltons criminal and technically illegal monopoly has also destroyed the any remnant of a Free Market.

August Busch III and his family are worth about 13 billion and they own the Sons of Silence motorcycle gang. The Buschs have high authority in the United States and are related to the Bush political dynasty and the Von Dem Bussche nobility in Germany. The Buschs have residences in Missouri which is the primary headquarters for the Bushs, Buschs, and Waltons. They have underground military bunkers in the Ozarks.

Neil Bush is a top member of the Bush dynasty and he is a banker and the Chairman of the Points of Light foundation which finances Luciferian gang stalking. Neil Bush was involved with the Silverado Savings & Loan banking scandal and today he is also Chairman of Singhaiyi a Chinese property development company as well as Chairman of A&A Consulting which works with Asian investors. Neil Bush admitted to having affairs with Asian women during his divorce. Neil Bush oversees and finances sex trafficking in Asia into the United States.

Prince Michael von Baden with Prince Bernhard von Baden and they are top authorities over Wall Street and financiers of human trafficking, gang stalking, propoganda, and terrorism.

Jeffrey Sprecher is the head of the Intercontinental Exchange and New York Stock Exchange and he is an agent of the Wurttembergs and Badens. Wall Street is used for concealing bribes through insider trading, rigging worth of products and companies, and corporate gambling. Corporations are defined as people with rights under "law" however corporations are not people so that is fraudulency.

Princess Victoria Bernadotte of Sweden manages and finances violent feminist cults who specialize in insane blasphemies, murder, and cannibalism. The royal family of Sweden have corporate shares in numerous banks and businesses in Sweden and they are likely worth billions.

Peter Wallenberg Jr. is a Swedish businessman and agent of the House of Bernadotte. The Wallenbergs are one of the most powerful European business dynasties and they control various companies and use charity foundations for financing criminal agendas. The Wallenbergs also financed Nazism and worked with some criminal Jews during WWII. The Wallenbergs also own SEB Group a large Swedish bank.

Orleans are a French royalty that own the New Orleans crime syndicate. The Wurttembergs are German businessmen and bankers that finance human trafficking through the Port of New Orleans which is infiltrated by black gangs. The state of Wurttemberg uses a black panther for its coat of arms and the Wurttembergs finance Black Panthers.

Nicky Oppenheimer is worth 7 billion and he is a part owner of Anglo-American corporation and involved with money laundering and criminal financing. The Oppenheims were originally employed by the House of Wurttemberg and today they are still Court Jews for the Wurttembergs and Badens. The Oppenheims finance racial conflicts in South Africa and they use child slave labor for their diamond mines. The Oppenheims also launder criminal profits through De Beers and they are business associates of the Rothschilds.

Prince Erich von Waldburg-Zeil and Trauchburg is an overseer of modern Nazism and an architect of zealous gang stalking.

Charles Schwab is worth 8 billion and his banking corporation manages over 3 trillion in assets. Charles Schwab is an agent of the Badens and Wurttembergs. The name Schwab derives from Swabia, Germany which is now parts of Bavaria, Baden, and Wurttemberg.

Prince Karl Friedrich von Hohenzollern-Sigmaringen with his wife. Prince Carl Friedrich is a top owner of the Gremium motorcycle gang and he is an overseer of the Bank for International Settlements or the BIS. The Hohenzollerns also founded Reichsbank which worked with the Nazis and the BIS.

Charles Wellesley the Duke of Wellington with Princess Antonia of Hohenzollern the Duchess of Wellington and Duke Charles Wellesley is a top British businessman and an authority over the City of London Corporation. Charles Wellesley has been a top executive for about 16 British companies and banks. The Wellesleys finance child trafficking networks and Druid cults that operate in forests and burn children alive.

Prince Joachim von Hohenzollern and Prince Friedrich von Hohenzollern and they are German bankers working with the Italian bank UniCredit. The Torlonias are married with the Borgheses and their Bank of the Holy Spirit is part of UniCredit. The Leiningens and Estes both have white eagles on their coat of arms because they are really from the same bloodline. Prince Heinrich of Hanover is a financier of human trafficking and he is also a Jesuitical manager of propagandists.

The Santo Domingos have also owned an apartment on 740 Park Avenue in Manhattan. 740 Park Avenue is a major headquarters for international criminals in New York and it is connected with a human trafficking network.

Princess Caroline of Hanover and Monaco is a leader of various Wiccan covens and she is a member of the royal House of Hanover and royal House of Grimaldi which rule the nation of Monaco.

Prince Ernst August of Hanover with his Russian wife Princess Ekatarina of Hanover and they are financiers of human trafficking. Lady Charlotte Wellesley with her billionaire banker husband Alejandro Santo Domingo whose Columbian family are worth about 15 billion. The Santo Domingos are involved with brewing companies, banking, and media and they have residences in South America and New York.

Prince George Friedrich of Hohenzollern-Prussia with Princess Sophie of Hohenzollern-Prussia and they are owners of the Gremium motorcycle gang, financiers of NWO propaganda, and they are top overseers of the Bank for International Settlements. The Hohenzollerns helped to put the Nazis into power during WWII and some Hohenzollern princes were also Nazis. The Nazis founded the Bank for International Settlements with the British Montagus through Baron Montagu Norman and they used the BIS for stealing wealth and gold from nations during WWII which was melted down at the Prussian mint owned by the House of Hohenzollern. The Hohenzollerns also founded Reichsbank and Deutsch Bank through charters.

Count Alexander von Isenburg with Countess Sarah von Isenburg and they work closely with the House of Hohenzollern. The Isenbergs are Roman Catholic and currently married with the Protestant Hohenzollerns. The name Isenburg means Iceburg and they were involved with sinking the "Titanic" likely with a secret German U-Boat which was part of an insurance fraud scheme. Prince Alexander von Furstenberg with Diane von Furstenberg. It appears that 740 Park Avenue has underground mafia built tunnels used for human trafficking. Elisabetta d'Udekem the sister of the Queen of Belgium. The Pallavicinis were given the titles of Dukes of Victory by the House of Savoy which previously ruled Belgium with Queen Maria Jose of Belgium who was a Savoy. Margrave Alphonso Pallavicini is an Austrian noble.

King Philippe of Belgium with Queen Mathilde of Belgium and they are managers of the Bank for International Settlements which is stealing wealth from nations through fraudulent tax contracts like the Belgian Scheldt Dues which steal money from American taxpayers. The United States has been in tax contract with the Kingdom of Belgium since the 1871 District of Columbia Organic Act.

Prince Lorenz of Belgium and Archduke of Austria-Este with his wife Princess Astrid of Belgium. Prince Lorenz is a managing partner at Gutzwiller bank in Basel, Switzerland and he has worked as a banker in Rome, London, and Paris. Prince Lorenz is a Austrian-Belgian-Italian royal who is involved with criminal financing of mafias and gang stalkers, money laundering for mafias like the Lucchese crime family, and funneling criminal wealth from private bank accounts of royals and nobles to and or from the Bank for International Settlements.

Prince Charles-Antoine Lamoral de Ligne La Tremoille holding hands with the President of Israel Rivlin Reuvin. Prince Charles-Antoine also owns a Swiss based gold and diamond mining company that has decade long contracts in South America.

Prince Emanuel de Merode is a high level Belgian noble connected with Africa. The Merodes are married with the Belgian Lignes and also with the Italian Massimo-Lancellottis. The Merodes have a bat on their coat of arms which is a symbol for Gothic bloodlines.

Charles Astor with Princess Eliane de Merode. The British Astors and Belgian Merodes have an alliance. The Belgian royals are Saxe-Coburg and Gothas and the British royals were originally the Saxe-Coburg and Gothas.

Prince Pierre D'Arenberg with Princess Marie-Christine D'Arenberg and Prince Pierre is a Belgian-French banker. The Arenberg family foundation finances the European Union's agendas. The Arenbergs work closely with the royals of Luxembourg, France, and Germany.

Peter Handschin, Stephane Gutzwiller, Francois Gutzwiller and Prince Lorenz of Austria-Este and they are the heads of Gutzwiller bank in Basel, Switzerland and they covertly work with the Bank for International Settlements. The Gutzwillers also control about 30 other banks in Switzerland through the Entris Banking Group headed up by Jurs Gutzwiller.

Prince Amedeo of Belgium the Archduke of Austria-Este with his wife Princess Elisabetta of Belgium and they are top managers of the Illuminati. money laundering and tax evasion operation and fined hundreds of millions by the United States government. The royals of Luxembourg often take the name Gabriel and they are part owners of financiers of the Gavrieli crime syndicate in Israel.

Alessandro Benetton is a financier of the Venetian Mafia and a financier for the Passi de Preposulos. The Benettos are worth several billion and they are from Treviso, Venetia north of Venice where the Passi de Preposulos reside.

Countess Beatrice Del Bono Venezze with Count Vittorio Del Bono Venezze and they are part owners of the Venetian Mafia and they are directly involved with child sacrifices.

Count Gian Luca Passi de Preposulo with his Hollywood wife Jessica Chastain. They are financiers of child trafficking networks and they are murderous blood drinking cannibals. Count Gian Luca is a part owner of the Venetian Mafia and a top authority in Hollywood and Scientology. The Venetian Mafia have a major operation in Los Angeles and Hollywood. Count Gian and Chastain are close friends with Will Smith and Jada Pinkett Smith and they are high level Scientologists and insane electronic terrorists. DARPA and Silicon Valley have weaponized modern electronics and Scientologists use neuro-bio hacking software programs like NEURON and GENESIS which secretly function through electronic signals and wireless frequencies.

Prince Valerio Massimo owns an investment firm in London and he has residences in Los Angeles and he oversees the Gambinos mafia faction in Los Angeles. The Gambinos are related to the Gambaro noble family of Italy which use a lobster on their coat of arms. Princess Alexandria has a lobster on her hat.

Prince Carlo Massimo has been the President of the Italian Knights of Malta and he is a top commander over various militaries around the world. Prince Carlo is a top authority over the Sovereign Military Order of Malta which is based in Rome and he also oversees royalty through the SMOM. Most royals are Knights of Malta or Knights of Saint John the Protestant equivalent to the Roman Catholic Knights of Malta. The Knights of Malta also own the Mount of Piety banking organization which likely owns hundreds of small banks around Europe and especially in Italy, Malta, and Switzerland.

Prince Stefano works as a fashion photographer and he is really a sex trafficker of women and children. Prince Tancredi is the primary owner of the Rathkeal Rovers Irish Mob and he is involved with thefts through museums and auction houses which are also used for money laundering. The name Tancredi derives from the name Thank-rath like Rath-keal. Prince Tancredi works with Christie's an international high end auction company. The Rathkeal Rovers are known for thefts at museums and auction houses.

Remo Ruffini is an Italian knight, businessman and international sex trafficker working with the Massimo di Roccaseccas and he is involved with fashion.

Frank Zac Goldsmith with Benjamin Goldsmith and their family co-founded various banks including Paribas and they finance shills, trolls, online terrorists, and hackers as well as London gangs and sex trafficking of underage girls in England. Their sister Gemima Golsmith's ex husband is Imran Khan and he is the current Prime Minister of Pakistan. Pakistani gangs are heavily involved with trafficking underage girls in England like the Rochdale child sex abuse scandal.

David Gold and David Sullivan are wealthy Jewish-British businessmen working with the London crime firms and they are involved rigging football or soccer games and financing sex trafficking rings.

Baron David Rene de Rothschild with Princess Olimpia Aldobrandini. Baron David Rene is the head of the House of Rothschild and he is a major financier of various criminal activities. The French Rothschilds are currently the head of the Rothschild dynasty and today they have branches in France, Switzerland, and London. The French Rothschilds are court factors for the Vatican and are titled the "Guardians of the Papal Treasure" in the Jewish Encyclopedia. Guardians are not owners. The Rothschilds have been in business contracts with the Torlonias who are the Vatican treasurers for centuries.

Don Giovanni Torlonia the Prince of Civitella-Cesi and the Torlonias are believed to be officially worth several billion in assets through their palaces and art. Prince Giovanni is an owner of the Kansas City crime family, Galveston crime family, Pittsburg crime family and a part owner of various factions of the New York crime families like the Genoveses as well as a high level authority over the Bank for International Settlements. The Torlonias are the private bankers in Rome and they own Banca del Fucino with the Borghese family. Banca del Fucino is also currently in banking contracts with the Rothschilds and it launders criminal profits of the mafia for the Black Nobility. The Torlonias operated as the mediators between the Rothschild's loans to the Vatican. The Torlonias are also married with the royal families of Luxembourg and Spain.

King Juan Carlos of Spain with Queen Sofia of Spain and they are top owners of the Mexican and South

American drug cartels. The Bourbons have a close alliance with the Black Nobility and the Italian Bourbons. The Bourbons are also Knights of the Order of the Garter and do business at the City of London Corporation where the Virginia Company was formed. The United States is a continuation of the Virginia Company and the Spanish Bourbons claim a portion of ownership over the United States in former Spanish territories like California and New Mexico.

Carlos Slim is worth over 50 billion and he is a boss and financier of Mexican drug cartels and he serves the Spanish House of Bourbon.

Prince Lorenzo was on the American show The Bachelor and he works in the cosmetics industry. The Borgheses are powerful bankers that have residences in Switzerland, Spain, Rome, Sicily, and the United States. The Borgheses founded the Bank of the Holy Spirit in 1605 which eventually merged with Capitalia and then with UniCredit. The Borgheses are part owners of UniCredit a major Italian and European bank.

Prince Pedro of Bourbon-Two Sicilies the Duke of Calabria is the Grand Master of the Spanish Sacred Constantinian Military Order of Saint George and the commander of numerous Spanish knighthoods connected with the Templars. Prince Pedro is an owner of some Calabrian mafia factions and a top commander of the Society of Jesus or Jesuits.

Ray Dalio is worth 18 billion and is a money launderer, criminal financier, and embezzler for Cosa Nostra and he mostly works for the Chigi-Albani Della Rovere and Bourbon-Parma families.

Prince Jaime of Bourbon-Parma with Queen Maxima of the Netherlands and he is from a Roman Catholic royal family of Italy and he is also a member of the Protestant Dutch royal family. The Dutch royals are major financiers of child trafficking networks in Eastern Europe.

Erik Prince is a covert Parmese Knight of the Sacred Military Constantinian Order of Saint George and he owns Frontier Services a private military company and formerly owned and ran Blackwater which was involved in murdering civilians in Iraq and trafficking weapons. King Willem-Alexander of the Netherlands is the "above the law" ruler of the Netherlands whose family created hundreds of international companies including banks and industrial merchant corporations like ABN AMRO bank. The Dutch law states that the monarch is inviolable which means not subject to law. King Willem-Alexander manages the Irish based Loyal Order of Orange a Masonic organization and he also oversees the RAND Corporation. The Dutch royals ruled over England, Scotland, and Ireland which is why Protestant Irish Freemasons are loyal to the Prince of Orange who is loyal to Roman Catholics and the Vatican. The Koch family migrated to the United States from the Netherlands and they are agents of the Dutch House of Orange-Nassau.

Prince Carlos of Bourbon-Parma with Princess Annemarie of Bourbon-Parma and he is a top manager of the European Union and he is the Grand Master of the Parmese Sacred Constantinian Military Order of Saint George an Italian Templar knighthood that oversees Jesuits.

Prince Lilio Sforza Ruspoli is a Roman banker and the former President of the Italian Knights of Malta as well as a top owner of the Rizzuto crime family and a part owner of most South American drug cartels. Prince Sforza owns mafia resorts on the Venezuelan island of Margarita and is involved with child sacrifices. Silvio Berlusconi is the former four term Prime Minister of Italy who is worth about 7 billion as the owner of Mediaset an Italian mass media monopoly. Berlusconi is a criminal associate of the Sicilian Mafia and he is an agent of the Black Nobility and House of Savoy.

Princess Giacinta Ruspoli is a top overseer of Wiccan-Amazon cults and she is involved directly with child sacrifices. Princess Giacinta is a noble of Rome, Holy Roman Empire, and Spain.

Kirsty Bertarelli and her husband Ernesto Bertarelli with Eva Herzigova. The Bertarellis are Italian-Swiss billionaires that work with the Corsinis and Savoys. The Bertarellis are involved with the pharmaceutical industry, chemical warfare, and also financing child trafficking networks.

Count Giangaleazzo Visconti di Modrone is a part owner of the Trafficante crime family and Seattle crime family which specialize in human trafficking and sex trafficking.

Leonardo Del Vecchio is mafia money launderer and criminal financier worth 25 billion and he is also an agent of the Sforza-Cesarinis and Viscountis. The Sforzas ruled the old commune of Vecchio where he takes his name and they also ruled Milan where Leonardo Del Vecchio is from.

Don Benigno Melzi d'Eril the Duke of Lodi and Count of Magenta is an overseer of Las Vegas and of Druid and Magi cults. The Melzi d'Erils have residences in Bellagio, Italy. The Bellagio in Vegas is named after Bellagio, Italy. Bellagio is also where the Rockefellers founded their global vaccination agenda.

Prince Prospero Colonna di Paliano the current Prince Assistant to the Papal Throne with his wife Princess Jeanne Colonna di Paliano and they oversee pedophilia networks within the Vatican and they also oversee the Knights of Columbus which have deeply infiltrated police agencies in the United States. The Colonna di Paliano family are owners of the Chicago Outfit, Colombo crime family, and Columbian drug cartels. John Viola is the United States Delegate for the Two Sicilies Sacred Military Constantinian Order of Saint George and he manages Italian-Bourbon knights in the United States which have infiltrated governments, military, law enforcement, and the judicial system. John Viola was also Jesuit educated at Fordham and his father Vincent Viola is a billionaire and associate of the Gambino crime syndicate.

Prince Charles-Emanuel of Bourbon-Parma is a part owner and manager of the New England crime family and an owner of mafias operating in Canada and Montreal. Prince Charles-Emanuel of an Italian noble in France. France heavily colonized Canada.

Duke Pierre Louis de La Rochefoucauld with his wife Duchess Sabine de la Rochefoucauld. The Rochefoucaulds are an old Roman Catholic French nobility that are loyal to the Orleans and French Bourbons.

Prince Amaury of Bourbon-Parma and Marquis Giorgio of Sanjust di Teulada are managers of MS13 and some Italian and French crime syndicates. They also work closely with Prince Giacomo Massimo-Brancaccio.

Prince Giacomo Leone Massimo-Brancaccio is an owner of MS13 and he is a top manager of Kabbalah

and also a top manager of gang stalking as well as the Gay Mafia and an overseer of faggot initiations within gangs. Prince Louis-Alphonse the Duke of Anjou is an owner of various South American and Mexican drug cartels and he is both a French and Spanish noble. Prince Louis-Alphonse is also closely related to the Franco family with Francisco Franco the Fascist dictator of Spain who reinstalled the House of Bourbon as the monarchs of Spain. Prince Antonio of Orleans-Braganza with Princess Christine of Orleans-Braganza and they are owners of Brazilian cartels and gangs.

Prince Jaime of Bourbon-Two Sicilies is a high level knight who manages Hermeticists and Wiccans.

Prince Eudes of Orleans with Princess Marie-Liesse of Orleans are part owners of the New Orleans crime family. The New Orleans crime family oversee black street gangs which have infiltrated the New Orleans Port Authority. The New Orleans crime family also get rid of bodies and evidence in the swamps and bayous.

Josselin de Rohan-Chabot the Duke of Rohan is a top manager of Kabbalah and Chabad. The Rohans were Princes of Leon in France.

Bon means good and Compagni means Companion a synonym for Fellow.

Lorenzo Fertitta who is an owner of Red Rock Resorts casinos and he is worth over 1 billion and he is the former majority owner of the UFC which is used for recruiting mafia enforcers. The Fertittas are worth between 7-9 billion and they are married with the Maceo family who were the documented bosses of the Galveston crime family of Texas.

Prince Fabio Borghese the Prince of Leonforte is a top overseer of the Sicilian Mafia. Leonforte is a commune in Sicily. The Leones are also high level Sicilian nobles and mafia owners who are connected with Rome and Hollywood.

Prince Ascanio Pacelli is a high level manager of Nazis, mobsters, and gang stalkers. The Pacellis are Italian papal nobles who made an alliance with Hitler and the Nazis.

Stefano Pessina is the CEO of Walgreens Boots Alliance and he is worth 10 billion. Stefano Pessina finances biological and chemical warfare through Alchemical secret societies like Hermeticists and Martinists and he works for the Colonnas and Orsinis.

Prince Oddone Colonna is a top overseer of the Oddfellow Order a Masonic organization involved with bestiality, transsexualism, pedophilia, and cannibalism. The Oddfellows are a British Masonic organization that are managed by the Barons of Strange. Strange means odd. The Barons of Strange bloodlines use the trisklion on their coat of arms. Sicily uses the trisklion on its flag.

Princess Luisa Orsini works in the fashion industry which is often used for sex trafficking and prostitution.

Prince Urbano Sciarra-Colonna-Barberini is a top authority over the Royal Order of Jesters and he also oversees a large faction of comedians in Hollywood. Prince Urbano is an Italian prince, actor, and comedian and from two ancient papal bloodlines. The Royal Order of Jesters is a Masonic organization. Freemasons all use the pillar or column for a primary symbol and most Masonic lodges have two

columns next to an altar. The Colonna name means Column and they have a column on their coat of arms and in front of their Roman palace. The Colonnas are top architects of Freemasonry.

Marchese Nicolo Cavalcanti di Verbicaro is a part owner of the DeCavalcante crime family of New Jersey and he is a high level Knight of Malta that works with the Chigis and Aldobrandinis.

Antonio Purini with Prince Camillo Aldobrandini. Prince Camillo is an owner of the Apulian Mafia and DeCavalcante crime family as well as a top manager of the Vatican, Jesuits, and Catholic priesthods. His son Prince Clemente Aldobrandini is a high level member of this family. Prince Camillo's brother the Duke of Brindisi is a primary owner of the Apulian Mafia and he resides at the Palazzo Antinori in Florence. The Aldobrandinis are heavily involved with child trafficking and pedophilia rings and they also manage the serial killer program. Prince Camillo Aldobrandini is the uncle of Princess Olimpia Aldobrandini the wife of Baron David Rene de Rothschild. The Jewish Rothschilds have a close alliance with the Roman Catholic Black Nobility.

Prince Mario Chigi-Albani Della Rovere the Prince of Farnese oversees Nazism, Zionism, Sovereign Military Order of Malta, Equestrian Order of the Holy Sepulchre as well as the Jesuits and Pope. Prince Mario is also a top owner of the Albanian Mafia and Rudaj Organization, a part owner of the Israeli Mafia and an occasional manager of the Gambino crime syndicate. The Equestrian Order of the Holy Sepulchre of Jerusalem is located at the Palazzo Della Rovere. During WWII Prince Ludovico Chigi was the Grand Master of the SMOM which engineered WWII on all sides. The Chigis have six hexagrams on their coat of arms which is a symbol for Saturn, also the symbol for Khazaria, and the symbol for Zionism and the hexagram is on the flag of Israel. The Chigi family covertly co-founded the Banca Monte dei Paschi di Siena or BMPS the oldest continual bank in the world. BMPS finances organized crime, gang stalking, and child trafficking and covers it up as "non performing loans" BMPS has also donated to the Clinton Foundation. The Georgetown Jesuit educated Bill Clinton bombed Yugoslavia and enabled the Albanian Mafia in taking over there. Prince Mario Chigi has also been investigated for tax evasion in the spectrum of hundreds of millions through shell companies in Bulgaria and through banks in Liechtenstein. The Chigis are married with the Sayn-Wittgensteins which are currently married with the Bavarian royals and they are currently married with the royal family of Liechtenstein.

Prince Ascanio Massimo-Lancellotti is an owner of the Sicilian Mafia and he is related to the Odescalchi family. The Massimo-Lancellottis still own a large castle in Campania, Italy and they are related to the Sicilian House of Lanza and together these families co-own the Lanza crime syndicate in the United States based in San Francisco.

Prince Domenico Napoleone Orsini is an owner of the Israeli Mafia, Ursino Ndrangheta mafia clan, Cleveland crime family and a top overseer of the Rosicrucian Order. The Orsinis have a rose on their coat of arms and they are top architects of Alchemy which is chemical witchcraft. The Orsinis are a major bloodline of the Black Nobility and they produced popes, dozens of cardinals and bishops and they have been major landowners with dozens of titles of lords, barons, and princes.

Prince Alois Konstantin Lowenstein-Wertheim-Rosenberg is a Bavarian noble and banker who is a Knight of the Equestrian Order of the Holy Sepulchre of Jerusalem, and he is a part owner of the Israeli Mafia. Prince Alois Konstantin worked for Merck Fink Bank which took over the Rothschild's Austrian bank branch during WWII.

Count Hubertus Fugger-Babenhause is a German financier who uses his charity racket to finance gang stalking, propagandists, and trolls.

Princess Maria Teresa von Thurn and Taxis with Princess Gloria von Thurn and Taxis and they are high level overseers of Wicca. The Thurn and Taxis family are managers of the Mars-Badger family which are worth about 70 billion. Taxis means badger and they have a badger on their coat of arms. Princess Gloria and her daughters are some of the most sadistic and torturous witches on the planet.

Count Alexander von Fugger-Babenhause is a financier of shills and trolls. The Fuggers were one of the wealthiest banking dynasties in Europe and today they use their charity racket to finance criminal operations.

Prince Wilhelm Albert von Wurttemberg the Duke of Urach is a high level member of the German House of Wurttemberg.

Prince Fritz von Thurn and Taxis

Count Carl Alban von Schoenburg-Glauchau with Countess Juliet von Schoenburg-Glauchau and their family are owners of the Jewish Mafia in Eastern Europe.

Alexander Flick with his brother Moritz Flick and the Flicks are billionaires that manage Nazism. The Flick family are worth at least 10 billion and during WWII they had tens of thousands of slave laborers working at their industrial company. The Flicks are also part owners of Mercedes-Benz and they are married with the Thurn and Taxis family and Italian nobles.

Prince Eduard von Habsburg is the Hungarian Ambassador to the Holy See and to the Sovereign Military Order of Malta.

Prince Rudolf von Croy is a Knight of Malta commander and a noble for the Habsburgs.

Count Andrea Czarnocki-Lucheschi is a commander of the IDF and an owner of the Israeli Mafia and an owner of the Lucchese crime syndicate and his wife is the sister of Prince Lorenz of Belgium who is a criminal banker in Switzerland and a managing partner at Gutzwiller Bank. Count Andrea also has offshore accounts in Luxembourg and his wife is an Austria-Este or Habsburg-Este. The Czarnocki-Lucheschis are a branch of the Lucchesi-Palli branch of Venice and they married with the Eastern European nobles the Czarnockis. The Lucchesi-Pallis of Austria manage the IDF through the Russian-Jewish Mafia and through Hungarian-Israeli agents like Benny Gantz. The Lucchesi-Pallis reside near Hungary. The Russian Mafia in New York pay tributes to the Lucchese crime syndicate. The Russian

Mafia in Eastern Europe are part Jewish.

Frank Stronach with Belinda Stronach is a money launderer for Austrian criminals and the Lucchese crime family. Stronach owns race tracks which are often major headquarters for mobsters who infiltrate gambling operations so they can fix wins for money laundering. The Stronachs work with the Lucchese crime family, Jewish-Russian Mafia, and Corsican Mafia. Stronach owns horse racing tracks in the United States including in Maryland used as money laundering fronts by the Corsican Mafia and Lucchese crime syndicate and they run the heroin market in the United States.

Count Umberto Lucchesi-Palli has been an Italian Ambassador to Morocco and he is a part owner of the Lucchese crime syndicate which receive tributes from the Russian Mafia. The Russian Mafia in Brighton Beach, New York pay tributes to the Lucchese crime family for allowing them to operate there and for protection. The Lucchesi-Pallis are both Italian and Austrian nobles and the Russian-Jewish Mafia have had documented meetings in Austria and a large faction of the Russian Mafia is really based in Hungary and not Russia.

Archduke Carl Christian von Habsburg with Archduchess Marie Astrid von Habsburg and they are top managers of Zionism and Swiss banking. The Habsburgs own an investment firm in Switzerland called AAA Gestion.

Baroness Nadine de Rothschild is a Swiss billionaire and Austrian noble under the Habsburgs. The Rothschild family often marry Roman Catholic women like with Princess Olimpia Aldobrandini, Baroness Nadine de Rothschild, and her son's wife Baroness Ariane de Rothschild. They were all Roman Catholic and Nadine and Ariane married with the Rothschilds and converted to Judaism. In Judaism the Jewish ancestry is passed to the children through the mother.

Prince Anton Esterhazy von Galantha is a high level Knight of Malta commander with authority inside the United States through the Florida based Knights of Malta.

Archduchess Francesca von Habsburg

Count Max von Thun and Hohenstein with Countess Gioia von Thun and Hohenstein and Count Friedrich von Thun and Hohenstein

Prince Mariano Hugo of Windisch-Graetz with his wife Princess Sophie of Windisch-Graetz who is from the House of Habsburg. Prince Mariano Hugo is a high level Knight of Malta and the SMOM ambassador to Slovenia as well as a knight of the Vatican and royal Savoy and Bourbon-Two Sicilies. Prince Mariano Hugo is also a part owner of a Naples bank and he is from Trieste, Italy right next to Austria and Slovenia.

Count Janos Esterhazy de Galantha is the Treasurer of the Sovereign Military Order of Malta. The Esterhazys have extensive wealth and manage the Jewish-Zionist Lauder family. The Esterhazys work at private banks in Switzerland, Austria, and Eastern Europe and they are also part owners of the



Russian-Jewish Mafia faction which operates in Eastern Europe and Israel. The Esterhazys finance their mafias to make snuff films which they use for recruiting and initiating people into the NWO.

Jane Lauder is a leader of Kabbalistic witches and she is worth 4 billion. Jane Lauder is involved with child sacrifices and they appear to work with the Lucchese crime syndicate. The Lauders are a top Zionist clan that oversee the World Jewish Congress and they have a close alliance with the Esterhazys.

Prince Alexander Schoenburg-Glauchau is a part owner of the Austrian-Jewish Mafia. The Schoen brothers are agents of the Schoenburg-Glauchaus and they own the company U-Haul and are worth about 6 billion. The Schoenburgs are imperial nobles under the Habsburgs and Wettins and they are mostly Roman Catholic. The billionaire Joe Shoen was Jesuit educated at Holy Cross.

Countess Roza Thun and Hohenstein is a Polish politician and a leader of witches.

Prince Paul-Philippe of Hohenzollern-Romania is an owner of the Romanian Mafia and an overseer of Israel through the Arison and Ofer families which have Romanian ancestry.

Prince Simon of Saxe-Coburg and Gotha-Kohary of Bulgaria is a part owner of the Bulgarian Mafia. Prince Simon is the former King or Tsar of Bulgaria and the former Prime Minister of Bulgaria which is now completely run by the Bulgarian gangsters like Boyko Borisov.

Prince Eric Sturdza a Romanian noble who owns a private bank in Switzerland and he has an alliance with Ruspolis of Italy and the House of Windsor through their Romanian ancestries. Prince Eric Sturdza is a money launderer and criminal financier for royals and nobles.

Princess Margareta of Hohenzollern-Romania is a part owner of the Romanian Mafia and she is an overseer of Israel and Zionism. When the royals of Romania lost their monarchy they moved to Switzerland. The Arisons and Ofers are Israeli billionaire clans that have ancestry from Romania. The Arisons and Ofers are part agents of the Hohenzollerns and top bloodlines of Israel.

Eyal Ofer is worth about 10 billion and he is an agent of the Romanian Hohenzollerns. The Ofers are one of the most powerful families in Israel and they are involved with real estate, investments, energy, and shipping companies. The Ofers finance corruption in Israel, finance organized crime, and they are involved with human trafficking.

Idan Ofer is an Israeli billionaire involved with oil and shipping companies. Idan Ofer is the Chairman of Israel Corporation which was founded by the Jewish Eisenberg family and they are a branch of the German Isenberg noble family which are currently married with the Hohenzollerns. The Ofers migrated from Romania to Israel. The Hohenzollerns were the last monarchs of Romania. The Ofer family are Court Jews working for the Hohenzollerns.

Prince Andrew Romanov is a top owner of the Russian Mafia in California. The Romanovs established 3 branches in the United States including in California where there is a large faction of the Russian and Armenian mafias. Prince Andrew was born in London and his family has a close alliance with the House of Windsor.

Prince Konstantin of Bulgaria is an owner of the Bulgarian Mafia. The Bulgarian royals now reside in Spain and they are a branch of the Saxe-Coburg and Gothas.

Princess Francois Sturdza with Prince Francesco Ruspoli and Cintia Vasconcelos Pino. The Sturdzas are Romanian nobles and the Ruspolis are descendants of the Rus people which founded Russia and were located in the region in and around Romania. The Romanovs originated in Romania. The Rus people were related to the Romani people which took over the Latin Kingdom and created Rome.

Prince Kubrat of Bulgaria is an owner of the Bulgarian Mafia and part owner of some Galician Mafia factions in Spain. Prince Kubrat is also a doctor and human flesh trafficker.

Don Juan Gomez-Acebo and Bourbon the Viscount of La Torre. The Gomez-Acebo family own an international law firm and they protect mobsters.

Grand Duke George Mikhailovich Romanov of Russia is a part owner of the Russian Mafia and he is from both the Russian House of Romanov and the Prussian House of Hohenzollern and he resides in Spain. Karl Marx was from Prussia and his Marxism influenced the creation of the Bolsheviks which took over Russia.

Don Benjumea de Soto Francisco de Borja with Princess Fabrizia Ruffo di Calabria. Don Benjumea is part owner of Mexican drug cartels and the Ruffo di Calabria family are part owners of the Calabrian Mafias or Ndrangheta. The Borja or Borgia family originated in Spain and established branches in Italy producing several popes. The Borgias were ruthless and attempted to take over Rome so the other Black Nobility banned them from Rome. Today the Borgias and Borjas are nobles in Spain and Naples and knights of the Italian and Spanish Bourbons.

Prince Marcantonio del Drago with Countess Giada de Dobrzenicz and Del Drago is an owner of the

Romanian Mafia and in Italy an owner of Roman mafia gypsy clans.

Count Jan Dobrzenicz is a Grand Master of the Order of Saint Lazarus which works with French and Swiss bankers as well as Lazard and the World Bank with a large faction of knights in Scotland that work closely with Scottish Rite Freemasons.

Don Carlo Emanuele Ruspoli the Duke of Morignano with Duchess Maria Ruspoli. These Ruspolis are Spanish nobles and they own some factions of the South American and Mexican drug cartels.

Don Luis Beltran Gomez-Acebo and Bourbon. The Archbishop of Los Angeles is Jose Gomez and he is an agent of the Spanish Bourbons. California is partly overseen by the Spanish royals because they settled and founded California which absorbed into the United States. The United States is a corporation and a continuation of the Virginia Company created by the English monarchs through a royal charter from the City of London Corporation. The Knights Templar were headquartered at the City of London and when the Templars were disbanded they reformed as the Order of the Garter. King Juan Carlos is a British Knight of the Order of the Garter because he has shares in the United States corporation.

Prince Alessandro Ruffo di Calabria with Prince Fulco Ruffo di Calabria and they are part owners of the Calabrian mafias or Ndrangheta. The Ruffo di Calabria family are also married with the Belgian royals and the Lucchesi-Palli family.

Don Cayetano FitzJames-Stuart and Martinez de Irujo is an owner of the Puerto Rican Mafia and Los Zetas drug cartel. The Puerto Rican Mafia was founded by the Martinez family which are a branch of Spanish nobles that settled in Puerto Rico.

Grand Duchess Maria Vladimirovna Romanov of Russia is an owner of the Russian Mafia and she operates in Spain and has an alliance with the Spanish royals and Spanish Ruspoli branch.

Don Francisco de Bourbon-Hardenberg and he is a top commander of the Order of Saint Lazarus.

Brianda FitzJames-Stuart and Martinez de Irujo

Don Francisco de Borja-Soto Moreno-Santamaria the Duke of Escalona is a Spanish noble and a top owner of a faction of MS13 and an owner of the Italian Camorra mafia clan the Spagnoli which means Spainards because they work in Spain. The Camorra clans were originally known as the Garduna which originated in Spain. The Italian Borjas are currently nobles in Naples where Camorra is headquartered. The Borjas established a large branch in South American and produced a President of El Salvador where MS13 originates. MS13 originated in El Salvadorian prisons and these gang members then migrated to the United States. The Borja-Papini family own GrupoBorja a large industrial company in South America.

Countess Esther Koplowitz is worth 1 billion and she is a high level Kabbalistic-Wiccan cult leader who works with the Austrian Habsburgs and Spanish Bourbons.

Marchioness Paloma of O'Shea with Queen Sophia of Spain and Ana Botin-Sanz de Sautuola O'Shea. The O'Sheas are part owners and top managers of Banco Santander which was established by the House of Bourbon. Santander has at least 1.5 trillion in managed assets. Ana Botin is the Executive Chair of Santander and she is also a British Crown knight.

Don Alfonso FitzJames-Stuart and Martinez de Irujo and the FitzJames-Stuart family are worth several billion and manage and own numerous organized crime groups in Mexico, Spain, and South America.

Marchioness Alicia Koplowitz of Bellavista who is worth several billion and she is a top manager of Kabbalistic-Wicca. The Koplowitz family are Spanish Jewish billionaires and they have an alliance with the House of Habsburg who formerly ruled Spain. The Koplowitz family migrated from the Habsburg empire to Spain.

Don Alessandro Borja Thyssen-Bornemisza with Blanca Cuesta

Donna Cayetana Alvarez de Toledo the Marchioness of Casa Fuerte. The Alvarez noble family which have numerous members are top owners of the Los Zetas cartel in Mexico. The Alvarez family are a large Spanish nobility connected with all the major Spanish royals and nobles. The Alvarez family are also involved with banking in Spain and Mexico.

Don Carlos FitzJames-Stuart and Martinez de Irujo the Duke of Alba is an owner of the Los Zetas cartel and Puerto Rican Mafia and his family are officially worth several billion. Don Carlos is a knight of the Italian House of Bourbon-Two Sicilies and a manager of the Order of Saint James which is a major Luciferian knighthood.

Anthony Crichton-Stuart is a manager of Scottish Rite Freemasonry and he also manages trolls and cults of pedophiles.

David Thomson the Baron Thomson of Fleet is a Canadian businessman worth 37 billion and he owns Reuters. Baron David Thomson works as an agent for the House of Stuart which owned much of the land in Canada through their Hudson's Bay Company and they are still nobles in Nova Scotia.

John Crichton-Stuart the Marquess of Bute with Serena Crichton-Stuart. The Stuarts are top managers of Scottish Rite Freemasonry from producing 6 Grand Masters of the Scottish Rite, co-managers of the Sovereign Military Order of Malta for producing 1 recent Grand Master, and top Zionist overseers with being married with the Guggenheim, Goldsmith, and Rothschild bloodlines.

Carole Middleton and the Middletons are part owners of Coutts private bank which is involved with money laundering for the Italian Mafia which have operations in Scotland and also for Scottish gangs in Glasgow as well as the House of Windsor.

Duke Torquhil Campbell of Argyll is an owner of the Scottish private bank Coutts which is involved with money laundering for a Glasgow gangs and a Gambino faction of the Italian Mafia operating in Scotland. The Campbells are also financiers, tax evaders, and money launderers for the British royal family. Numerous Italian and Sicilian noble families have married with Scottish nobles. The Campbells also manage a faction of Scottish Rite Freemasonry.

The Mormons were also founded by Freemasons.

Frederick Vane-Tempest-Stewart the Marquess of Londonderry and his family is married with the Jewish Goldsmith bankers.

Graham Wellesley the Earl of Cowley is a British financier of gang stalking and human trafficking. Graham Wellesley co-founded Wellesley & Co. a British bank and he is the brother of the Duke of Wellington.

Duke James Hamilton of Abercorn is a high level authority over Order of the Garter a reformed Templar Order which oversees banking and business at the City of London Corporation.

Baron John Sainsbury of Preston Candover with Lady Anya Linden of Preston Candover

Edward Spencer-Churchill is a cousin of Prince William and Prince Harry and he is also a business associate of Prince Valerio Massimo di Roccasecca and a top manager of gang stalking and terrorism.

Ivar Mountbatten

Joseph Kennedy III is a political authority in the United States and the Kennedys are believed to be worth at least 1 billion. The Kennedys work closely with the Irish Mafia and they are bosses and part owners of the Spillane crime family.

Desmond Guinness is a top authority in Ireland. The Guinness family owned Guinness Mahon bank and they also married with the Rothschild banking family and German House of Hohenzollern. The Guinness are top Irish bankers and top authorities in Ireland.

Duke Peregrine Cavendish of Devonshire with Duchess Amanda Cavendish. The Cavendish family are top British nobles involved with international business like the company Sothebys.

Arthur Guinness the Earl of Iveagh is worth about 1 billion and he is a financier of blood trafficking and he is a commander of gang stalking and terrorism.

Edward Kennedy Jr. is a top political authority in the United States and he works with the Irish Mafia and Hell Fire Club as well as criminals in the United States Air Force.

William Russell is the Lord Mayor of the City of London Corporation which oversees most major industries in international business. The City of London issues royal charters which includes hundreds of influential banks and businesses. The Knights Templar were headquartered at the City of London which is why it uses the Red Cross of Saint George which was also used by the Templars. The City of London is a one mile square block inside of London and it designed with an inner and outer temple. The City of London Corporation was given its sovereignty from the Kingdom of England under King John through the Magna Carta under orders from the Pope of Rome. During the 13th century the Kingdom of England was a vassal state of the Vatican.

Patrick Guinness is a top authority in Ireland and a financier of the Irish Mafia.

John Grayken is the owner of Lone Star Funds and he is a financier of the Irish Mafia and the Aryan Brotherhood of Texas. John Grayken is also a top commander and financier of the Hell Fire Club.

Stephen Hearst is a major landowner with hundreds of thousands of acres for timber and cattle. The Hearsts also owned gold mines which is where they obtained a portion of their wealth. The Hearst family are worth about 28 billion and they are one of the most evil families in the United States.

James Hamilton the Marquess of Hamilton with Marchioness Tanya Hamilton. The Hamiltons are a high level Scottish-Irish nobility and they are directly involved with Freemasonry.

The Disneys are business partners with the Hearsts and both the Disneys and Hearsts have old French ancestry which migrated to Ireland before moving to the United

States. They are from the same clan. Tim Disney is the Director of Shamrock Capital Advisers which is part of their family's investment firm Shamrock Holdings. The Disneys are Freemasons and they run a massive pedophilia ring in the United States.

William Randolph Hearst III is Chairman of Hearst Corporation which owns a mass media monopoly. The Hearst family are worth nearly 30 billion and they have Irish ancestry and they work closely with the Disney family. Caroline Freud another ex-wife of Matthew Freud is also the ex wife of Charles Spencer the brother of Princess Diana. The Freuds are working closely with the Spencers. Matthew Freud is the owner of Freud Communications and he is the great grandson of Sigmund Freud the fraudulent psychoanalyst.

Duke Alexander Douglas-Hamilton of Hamilton and Duke of Brandon with his wife Duchess Sophie Douglas-Hamilton. The Hamiltons are involved with managing Pinkerton through their relatives which was founded by Scottish Freemasons. Pinkerton now part of Securitas AB is involved with criminal espionage, cyber terrorism, computer hacking, and intellectual theft.

Count Gustaf Douglas is the owner of Securitas AB and Pinkerton who is worth 4 billion and he is involved with criminal espionage, violation of human rights, and intellectual property theft.

Prince Max of Liechtenstein the CEO of the private bank Liechtenstein Global Trust which is involved with money laundering and criminal financing.

Princess Anna Maria Quinones with Prince Idris Abdulla al Senussi and Princess Maria Pia Ruspoli

King Felipe Bourbon VI the King of Spain, Leon, and Jerusalem with Queen Letizia of Spain. King Felipe VI is a top owner of most Mexican and South American drug cartels and he is a top authority over Kabbalah and an owner of Banco Santander which has large banking operations in Switzerland. Kabbalah was developed in Leon, Spain. The Bourbons created Banco Santander through a royal charter. The Casanova family are Spanish-Italian nobles who established a branch in Switzerland that have ruled Switzerland as politicians. The Bourbons have hundreds of billions in private banks in Switzerland through their corporate charters and profits from drug cartels.

Antonio Del Valle Ruiz is a billionaire and top authority over various Mexican drug cartels and he works for the Spanish House of Bourbon. The Mexican drug cartels have a close alliance with the Chicago Outfit, Galveston crime family, and Kansas City crime family which oversee the drug trafficking from Mexico into the United States. They use street gangs to distribute the drugs while the Italian crime families oversee the gangs and take tributes. The Sansones are a Sicilian nobility, also a wealthy real estate family in Missouri, and there are Sansones that are convicted mobsters in the KC mafia. The Kansas City crime family of Missouri also work with the Fiocchis an Italian family which own an ammo plant in Springfield, Missouri. The Fiocchis secretly employ contract killers and traffic guns and ammo. The Torlonias are married with the House of Bourbon the monarchs of Spain. The Torlonias also own the only private bank in Italy called Banco del Fucino which is used for money laundering mafia profits.

Agustin Carstens is the General Manager of the Bank for International Settlements and he was educated in Chicago and is a Mexican banker who works as an agent for the Spanish Bourbons and Roman Black Nobility. Mario Draghi, Fabio Panetta, and Ignazio Visco are all Italian bankers connected with Rome who also work as top directors at the Bank for International Settlements. The Bank for International Settlement is the largest criminal bank on the planet and it extorts governments, finances organized crime, finances wars, finances gang stalking, and it finances human trafficking.

Prince Carlo of Bourbon-Two Sicilies with Pope Francis who is a Jesuit priest. The Italian Bourbon-Two Sicilies and Bourbon-Parma families were created through a marriage with the House of Farnese and Spanish Bourbons. The Farnese family officially established the Society of Jesus or Jesuits through their Pope Paul III or Alessandro Farnese who issued the papal bull Regimini Militantis Ecclesiae and that established the Jesuits as an official priesthood of the Roman Catholic Church. The Farnese family resided in the Farnese Caprarola a pentagonal fortress which is the basis for the United States Pentagon. Jesuits specialize in infiltrating militaries and intelligence agencies and numerous secretaries of defense, military generals, and CIA directors were Jesuit educated.

The Cuban born Fanjul brothers with Jose Fanjul on the left and Alfonso Fanjul Jr. on the right. They are worth about 8 billion and own Fanjul Corp. a large sugar monopoly. They both currently live in Florida where the Cuban Mafia are also headquartered and they own hundreds of thousands of acres in the United States and the Dominican Republic which is where they traffic cocaine from into the United States. The Castro family of Cuba are Jesuits and descendants of the Spanish-Italian Castro noble family and they are agents of the Bourbon-Two Sicilies which are the Dukes of Castro. Alfonso Fanjul Jr. was Jesuit educated from Fordham and the Fanjuls are criminal agents of the House of Bourbon-Two Sicilies and Spanish House of Bourbon.

Don Francesco Theodoli is a top owner of mafia operations in Miami. Chris Paciello is a mobster running night clubs in Miami and he works closely with actors and musicians like Rick Ross and Madonna. The Theodoli branch that own Magnum Marine live in Miami, Florida.

Prince Giuseppe Lanza di Scalea is a part owner and overseer of the Sicilian Mafia and a top owner of the Lanza crime family of San Francisco which now has operations on the East Coast and they have also infiltrated the FBI. The Lanza mobsters were involved with Sandy Hook which was a fake mass shooting carried out by child trafficking mobsters and designed to disarm Americans or target Americans who speak out against the crime of staging mass shootings of children.

Daniel Gilbert is worth about 7 billion and he is a top Jewish Mafia associate of the Detroit Mafia who is involved with criminal financing, bribery, and money laundering. Daniel Gilbert renamed his casino company Jack Entertainment to honor the current Detroit Mob boss Jack Giacalone. Dan Gilbert also bribed referees so his team the Cleveland Cavaliers would win especially with the excessive fouling from his employee LeBron James. The Detroit Mafia make 1-2 billion per year and they also run the Teamster unions which extort businesses like the auto industry. The Detroit Mafia disappeared Jimmy Hoffa whose son James Hoffa Jr now runs the International Brotherhood of Teamsters as General President. The Detroit Mafia was also behind the multi billion dollar Auto Bailout and Italian takeover of Chrysler.

Lorenzo Rocco de Torrepadula is from a large Italian nobility and he is an American-Swiss banker who worked for Credit Suisse and currently works for REYL and he is involved with money laundering and criminal financing for organized crime. Prince Augusto Ruffo di Calabria with Princess Scilla Ruffo di Calabria. Prince Augusto is a top owner of the Calabrian Mafias or Ndrangheta which make tens of billions per year.

Rocco Commisso is a Calabrian born American businessman worth 5 billion and he is the founder and owner of Mediacom a major television broadcaster in the United States, a Board Director for CSPAN, and a banker who worked for Chase Manhattan and the Royal Bank of Canada. The Commissos are also a top Calabrian crime family or Ndrangheta mafia clan which have large operations in Canada. Rocco Commisso is a top boss of the Commisso crime family and Ndrangheta and he works for Prince Augusto Ruffo di Calabria and Prince Pedro of Bourbon-Two Sicilies the Duke of Calabria.

Baron Fabrizio Galli-Zugaro is an owner of the Dixie Mafia. The Galli-Zugaros oversee Zug, Switzerland and they are intermarried with the Lucchesi-Pallis, Gaetanis, and Massimos. The Lucchesi-Pallis also married with nobles of Zug, Switzerland.

Countess Marisela Federici is a top manager of Democratic politicians around the world and she is a high level witch involved with child sacrifice.

Prince Roffredo Gaetani-D'Aragona-Lovatelli is a top owner of the Gotti faction of the Gambino crime syndicate and a top owner of the Philadelphia crime family.
